PURPOSES & DISCLOSURES

ExxonMobil Petroleum and Chemical BVBA appreciates your interest in the *Mobil 1™ Entertainment Download Promotion* (the “Promotion”). Your privacy is important to us and we want you to understand our practices with respect to gathering information from visitors and with respect to the uses we make of that information.

This Privacy Statement applies to information collected through the Promotion. Participation is voluntary and subject to this this Privacy Statement and the General Terms and Conditions.

PERSONAL INFORMATION

The Personal Information you provide to us will be used by ExxonMobil Petroleum and Chemical BVBA and ExxonMobil affiliates across Europe (collectively referred to in this statement as “ExxonMobil”) and/or contracted companies, only for the purpose of this Promotion.

You may visit different websites as part of this promotion which are subject to different privacy policies and as such we advise that you check each website for the relevant policy.

INFORMATION AND USES

When you visit our website associated with The Promotion, our web servers automatically gather information that allows the site to

communicate with your browser during your visit. We also use Google Analytics to track aggregated statistical information, such as the number of visits to the site, which parts of the site visitors select, IP address (the Internet address assigned to your computer from your Internet Service Provider), domain type, browser type (e.g., Firefox, Chrome, Edge or Internet Explorer), date, and time of day. We use this information for statistical purposes that help us design and administer the website as well as measure and improve the Promotion. Those types of information do not disclose Personal Information that would permit us to identify or locate individual visitors.

The collection and use of Personal Information, that is, information that could identify a specific individual such as name, address, phone numbers, car licence plate, e-mail address, date of birth, has privacy implications. If during your visit you decide to sign up to the Promotion, you will provide us with Personal Information.

The Personal Information you provide to us during sign up will be used only for the purpose of this Promotion to enable us to give you appropriate access to various websites, pages and content, as well as to assess and deliver the Reward to you via e-mail. Occasionally your contact details may be needed so that we can contact you and ask for further information relating to your claim, as detailed in section 4 and 5 of the Promotion Terms and Conditions.

The Personal Information that you provide for the purpose of this Promotion will be held until the end of the promotion and up to 18 months afterwards for administration purposes e.g. verification Rewards, fraud checks etc.

If you tick the box requesting to be kept informed of updates from ExxonMobil when entering the Promotion, your data will be held by ExxonMobil and occasionally we will send marketing information and news that we deem as relevant to you, until you elect to discontinue receiving them.

If you do not elect to receive either such communications or if you elect to discontinue receiving them, then we will not send or will cease sending them to you.

As explained below in the section on Data Transfers, we do not distribute, lease or sell Personal Information to third parties for the purpose of allowing them to market their products and services to you.

INFORMATION FROM MINORS

While the Promotion may be of interest to Minors, ExxonMobil does not seek through the Promotion to gather Personal Information from or about persons under the age of 18.

DATA TRANSFERS

Communicating via the Internet and sending information, products, and services to you by other means involves your Personal Information passing through or being handled by third-parties, but ExxonMobil does not sell or distribute your Personal Information to third parties for purposes of allowing them to market their products and services to you.

We employ other companies and individuals to perform functions on our behalf. Examples include fulfilling orders, deliveries, sending postal mail and e-mail, removing repetitive information from customer lists, analysing data, providing marketing assistance, processing credit card payments and providing customer service. They have access to Personal Information needed to perform their functions, but may not use it for other purposes.

We may transfer the Personal Information we collect about you to countries other than the country in which the information was originally collected. Those countries may not have the same data protection laws as the country in which you initially provided the information. When we transfer your information to other countries, we will protect that information as described in this Privacy Statement. By submitting data in the Promotion and accepting the terms of this Privacy Statement, you are providing consent to these transfers, including cross-border transmission of data covered by this Privacy Statement.

SENSITIVE INFORMATION

ExxonMobil does not seek any sensitive information from visitors to our Promotion, unless legally required to do so. Sensitive information includes a number of types of data relating to: race or ethnic origin, political opinions, religious or other similar beliefs, trade union membership, physical or mental health, sexual life or criminal record. We suggest that you do not provide sensitive information of this nature to us.

YOUR RIGHTS

When living in a country with comprehensive data privacy laws, certain rights in relation to the information collected may apply, including the right

to know and see what personal information is processed; the right to have inaccurate personal information corrected or deleted; and the right to withdraw consent to the processing of the personal information.

You can request the removal or modification of your Personal Information by contacting us in the methods provided below. We will then make a reasonable effort to accommodate your request.
